I extend congratulations to the leadership and membership of the American Chamber of Commerce of Guyana (AmCham) on the occasion of their fifth anniversary.

Since its establishment in 2018, AmCham has played an important role in Guyana's economic development through the facilitation of investment and trade between Guyana and the United States. AmCham has enabled the expansion of American business presence and relations in Guyana to the mutual benefit of both Guyanese and American companies. The United States is our leading trading partner and the Chamber's role is all the more important, given that the United States is one of our major diaspora centres.

As testimony to the country's strengthened relations with American companies, the Government of Guyana has engaged an American company in the single largest Engineering, Procurement and Construction (EPC) contract undertaken for the construction of the integrated natural gas liquids plant and the 300 MW combined cycle gas turbine power plant within the Wales Development Zone. This project will directly cut national emissions by 70 percent. This flagship project, combined with massive investments in the Amaila Falls Hydro Power Project and other alternative energy investments, will reduce our energy costs by 50 percent while reliably and adequately meeting the energy demands of our growing economy and unlocking the potential of the manufacturing and industrial sector.

In 2022, Guyana's economic growth was an estimated 62.3 percent, making it the fastest growing economy in the world. For the period 2023 to 2026, Guyana is projected to grow by an average 25 percent annually.

Recognising the importance of a strong diversified economic base, the Government of Guyana, even in the earliest days of oil production, placed the highest level of importance on a strong non-oil economy. Our policies have been focused on modernising the traditional pillars of the economy and catalysing a rapidly growing and highly competitive non-oil economy. This is evident with Guyana's non-oil economy growing by an estimated 11.5 percent in 2022, building on the 4.6 percent growth recorded in 2021, and over the medium-term is forecasted well above global levels.

Through its continued facilitation of trade and investment forums, AmCham continues to fulfil its mandate in supporting US based business interests in Guyana. With its membership growing to 183 in 2023, AmCham continues to contribute to strengthen bilateral relations between Guyana and the United States.

The Government of Guyana remains firmly committed to strong partnership with the private sector and will continue to maintain a conducive environment for private sector investment and growth. As we continue to welcome investors to contribute and participate in the building of our new economy, it is important to maintain a strong appreciation of the local content requirements, particularly in relation to the Oil and Gas sector, and I urge private sector representatives to make the necessary linkages and networks to strategically benefit from the advancement and progress currently underway. It is not by happenstance that AmCham's addition to Guyana's private sector arena came at the pristine time of Guyana being well on her way of unlocking the exponential economic opportunities that characterise her current existence.

Equally, history would unreservedly demonstrate that Guyana's momentous independence is also symbolic with the establishment of Guyana – United States of America (US) diplomatic relations. GUYANA EMERGES AS PREMIER INVESTMENT DESTINATION IN THE REGION

Guyana has rapidly risen to prominence as the leading investment destination in its region, drawing attention from global investors due to our robust democratic principles, transparent and accountable governance, and a well-defined, results-oriented development agenda. The government's comprehensive development plan encompasses multiple economic sectors, allowing for the identification of investment opportunities for both domestic and international investors.

Strategic allocation of revenues from the oil and gas sector has facilitated the expansion and modernization of established sectors, such as agriculture, tourism, climate services, and energy. Owing to its historically diverse economy, Guyana has demonstrated resilience against the risks associated with the Dutch Disease.

The PPP/C Government, in power from 1992 to 2015, inherited a bankrupt economy and successfully transformed it into one with competitive GDP growth across all non-oil sectors, even before the discovery of oil.

The PPP/C Government, upon returning to office in 2020, has shown unwavering commitment to long-term sustainability across various sectors, exemplifying the effectiveness of our economic model. Investors who have entered the Guyanese market have praised the country's President, Dr. Mohamed Irfaan Ali for his visionary leadership, emphasizing the importance of national infrastructure, education, and healthcare transformation, key elements for investment.

Prospective investors are advised to review the Low Carbon Development Strategy 2030 to gain insight into Guyana's economic potential. The country's economic performance has been compared to a high-performing stock (1GY - One Guyana), with a consistently rising share price. Key economic indicators, including GDP growth, GDP per capita, balance of payments, and the Natural Resource Fund, all suggest a robust and high performing economy with pragmatic projections. The International Monetary Fund (IMF) forecasts that Guyana will experience a compounded annual growth of over 30% in its GDP per capita between 2020 and 2024.

The year 2023 marks a pivotal moment for Guyana as it observes substantial investments in the oil and gas sector. Government-led initiatives, such as the construction of a new 300MW power plant, a 25% reduction in the regional food import bill by 2025, auctioning of new offshore oil blocks, increased renewable energy microgrids in rural areas, and the establishment of cutting-edge hospitals and hotels, provide a favorable environment for investment opportunities in the subsequent years.

These investments are anticipated to propel growth in sectors such as agro-processing, large-scale farming, and manufacturing, supported by a 50% reduction in energy costs. Guyana's abundant natural resources, including high-grade silica sand and bauxite, are expected to attract companies interested in producing solar panels, glass, and aluminum.

Guyana continues to attract Foreign Direct Investment (FDI) in significant values which has originated from diverse global sources, including Europe, North America, China, India, the Middle East, Great Britain, and the Caribbean.

Additionally, Guyana's local private sector and international diaspora have demonstrated significant confidence and engagement, investing in large-scale projects such as branded hotel chains, mega farming in soybean and corn, fabrication and engineering services for future FPSOs, and value-added products reaching broader markets.

The Government's investment regime is very attractive and under the Investment Act, the Government of Guyana provides various assurances to investors with respect to any investment made in Guyana with fiscal incentives, corporation tax holidays, repatriation of dividends, earnings and capital, double taxation treaties, and favorable trade agreements as applicable. Guyana's location, trade, and investment agreements facilitate access to key markets. Guyana offers strategic geographic positioning to investors.

The trade relations and agreements regional, multilateral and bilateral, allow easy access to major markets and protect investors. Guyana is a signatory to several trade, investment and economic agreements which facilitate market access.

We encourage you to explore Guyana and the lucrative investment possibilities in our rapidly expanding economy. Our Investment Team welcomes you to Guyana and stands ready to facilitate your investment.

On January 23, 2018, Mr. Zulfikar Ally, Mr. Clairmont Cummings, and Ms. Iman Khan met with Mr. Devindra Kissoon in his law office at London House Chambers to initiate the legal framework for the formation of AmCham Guyana. The establishment of the chamber on August 13, 2018 was enthusiastically embraced by the then U.S. Ambassador, Mr. Perry Holloway, and by the local private sector community. The group approached representatives of 17 prominent companies from both American and local origins, and on June 1, 2018 an interim board comprising of the initial members was installed to guide the new chamber through its first year and towards its accreditation process.

Since our establishment in 2018, AmCham Guyana has seen tremendous growth and expansion, with the intention of boosting investor confidence in Guyana's development possibilities and improving the ease of doing business in the country. The Chamber now has over 175 members representing a wide range of sectors, including local and international SMEs, conglomerates, and multinational corporations. The Business Support, Consulting, and Logistics Sector has especially seen a significant increase in participation, accounting for more than 20% of our total membership. There has also been an increase in the number of companies providing Oil and Gas Support Services, Construction, Importation and Distribution, and Freight Forwarding Services.

I Background

AMCHAM GUYANA INC. was incorporated in the Co-operative Republic of Guyana on April 23, 2018 under the Companies Act 1991 and was launched in August 2018. The objectives of the entity are as follows:

To promote America-Guyana trade and business

To create new opportunities and improve market access for America-Guyana goods and services

To provide an economic, social and policy platform for its members

To encourage networking and build valuable business connections

To promote mutually beneficial business relations and partnerships between Guyanese and American companies

To help promote corporate social responsibility and sustainable development in Guyana

2 Basis of preparation and accounting policies

(a) Accounting Convention

These financial statements have been prepared under the historical cost convention and no account has been taken of inflation. The accounting policies conform with the International Financial Reporting Standard for Small and Medium-sized Entities.

(c) Computer, office equipment and furniture

Computer and office equipment are measured at cost less accumulated depreciation and impairment loss. Depreciation is charged so as to allocate the costs of the assets less their residual value over their estimated useful lives, using the reducing balance method. Depreciation is prorated in the year of acquisition and no depreciation is charged in the year of disposal.

The rates used are as follows:-

Computer and office equipment 50%
Office furniture 20%

(d) Income

The source of income comprised mainly of member fees, personal contribution and fund raising activities.

(e) Expense recognition

Expenses are recognized on the accrual bias.
